

Terms and Conditions

General

1. Offer is subject to availability.
2. Rates are in MOP/HKD.
3. All rates are in MOP/HKD and subject to 5% Government Tax and 10% Service Charge.
4. Package inclusions are on a per stay basis, and all must be redeemed before check out.
5. Unused package benefits cannot be reimbursed or redeemed for cash either in full or in part.
6. No tables may be reserved prior to breakfast. This is on a first-come, first-served basis.
7. Rates are for single or twin occupancy in a room.
